Product Application Instructions

The purpose of these instructions is to establish appropriate guidelines to be taken that assure the interior and exterior of facilities are kept in a clean and sanitary manner.

These instructions apply to all employees or sub-contracted individuals involved with the cleaning of facilities which have been determined to require disinfection and antimicrobial surface treatment.

All facility areas shall be thoroughly cleaned and disinfected via the methods outlined within these instructions, on a routine schedule to be determined and implemented by company officials.

CLEANING – Refers to the removal of surface particulates, dirt, grime, residue.

DISINFECTION – The act of eliminating microbes/bacteria through the use that may or may not have adverse health effects on people and domestic animals.

ITEMS NEEDED TO BEGIN - Gather materials to treatment site:

- 1) Cleaning supplies to include water, bucket, and microfiber towels, SmartTouch® disinfectant, BioProtect RTU or 500
- 2) Application Equipment: Trigger sprayer, pump sprayer, fogger, electrostatic sprayer
- 3) Facilities shall be cleaned/washed per company policies

COMMON AREAS TO CLEAN

1) Door handles, register areas, chairs, breakrooms, restrooms, floors, trash areas, storage areas, offices, shipping and receive area, desks tables, countertops, walls. Touchpoints.

APPLICATION

Surfaces must be thoroughly cleaned and disinfected (follow product label and recommended dwell times).

EQUIPMENT – SPRAYERS - Pump Sprayers, Foggers, Electrostatic Sprayers

Product can be applied using any commercial sprayer available on the market. Follow instructions for the equipment you are using. Square foot coverage is based upon your sprayer equipment specifications.

Make sure surface is fully covered and wet. Once it dries a covalent biostatic bond is created.

STEP 1: Clean and remove all surface dirty, grime, and residue. You can utilize approved products by your company officials. SmartTouch® can be used with microfiber towels to remove dirt and grime.

STEP 2: Disinfectant, utilizing SmartTouch® and your preferred application equipment method. Apply SmartTouch® by sprayer, electrostatic sprayer, or fogger to all areas of the interior. Let stand for 10 minutes till dry.

STEP 3: Antimicrobial Shield, utilizing BioProtect RTU or 500 (concentrate) and your preferred application equipment method. Apply BioProtect by sprayer, electrostatic sprayer, or fogger to all areas. Let stand for 10 minutes till dry.

The applied surfaces have now been disinfected with BioProtect and retains biostatic shielding for up to 90 days. Reapplication to be conducted on routine schedule determined by company official.

Follow-Up utilizing the BioProtect Hand Sanitizer that gives up to 6 hours of extended protection.
